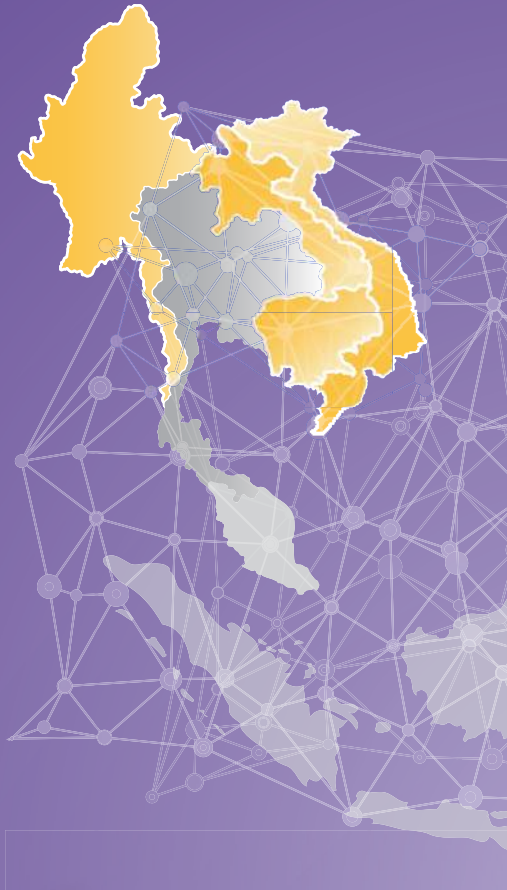

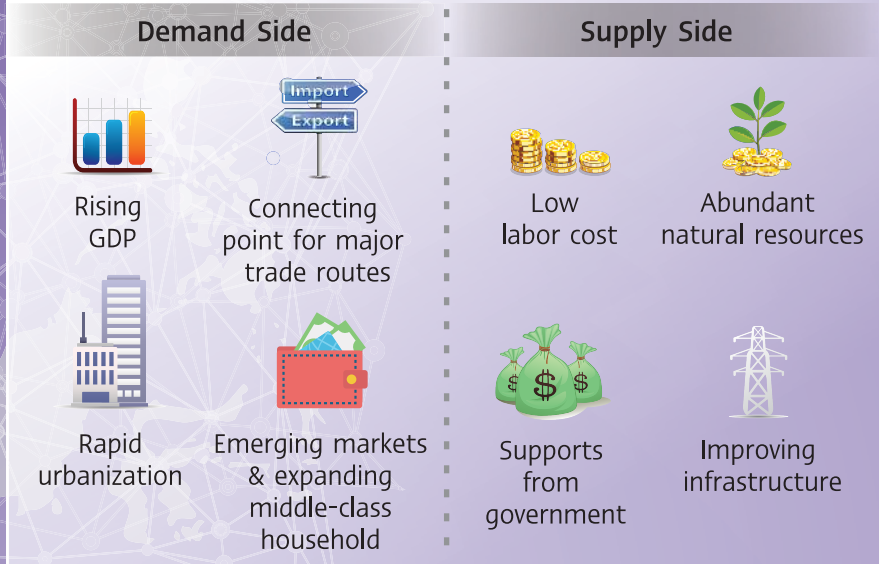

Opportunity seeking in related businesses could be profitable, particularly for industries linked to infrastructure investment of the CLMV.



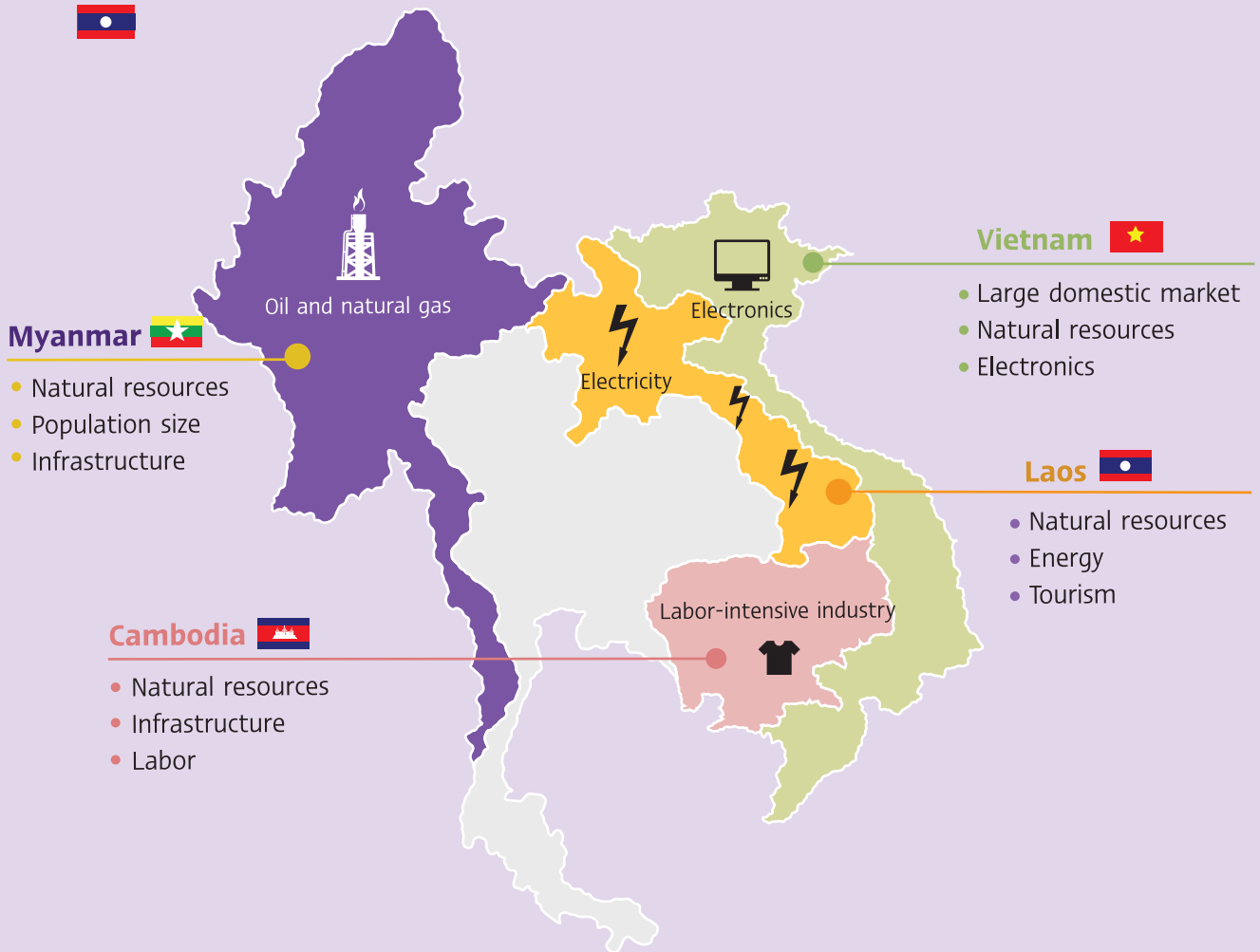
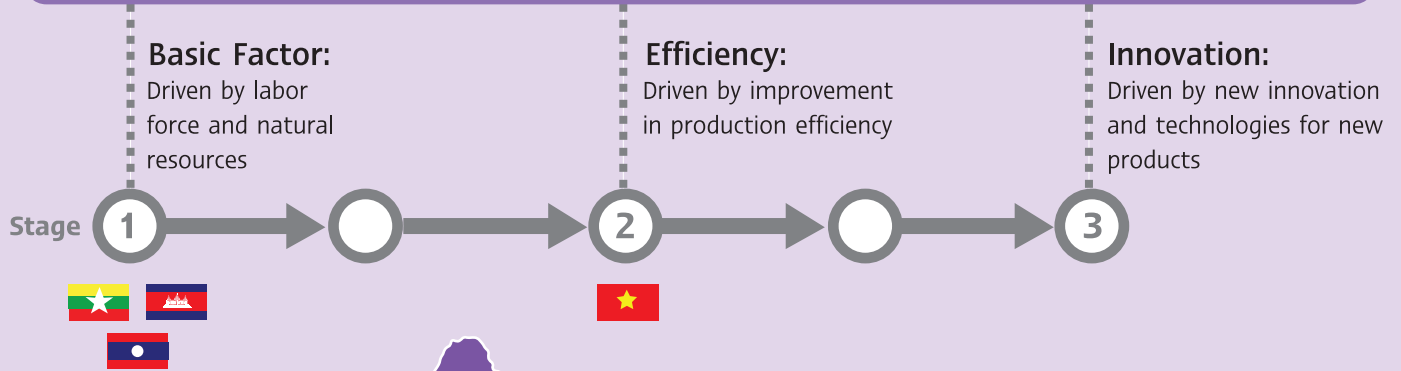

Which Thai business sectors stand to benefit?



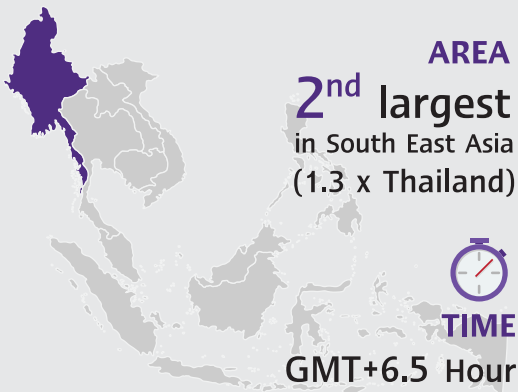

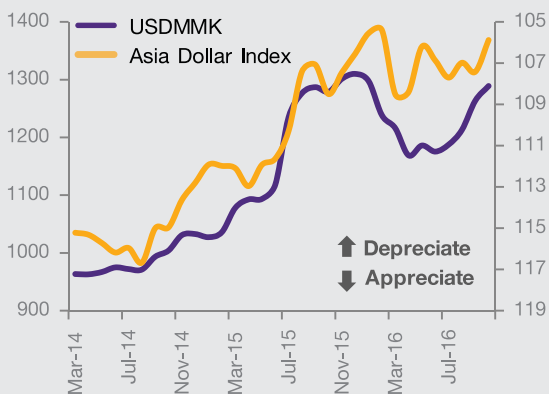

Myanmar's continuous efforts to join global markets have remarkably led to significant improvement in its domestic markets and progress in economic and political development. Despite leadership changes, there have been no major policy shifts and new political leaderships continue to support economic development and attract more foreign direct investment.

According to the IMF, Myanmar's GDP is expected to grow by 8.1% in 2016 and around 7.7% in 2017. Over the coming years, the opening up of the economy combined with greater political stability will certainly help boost its future economic growth.

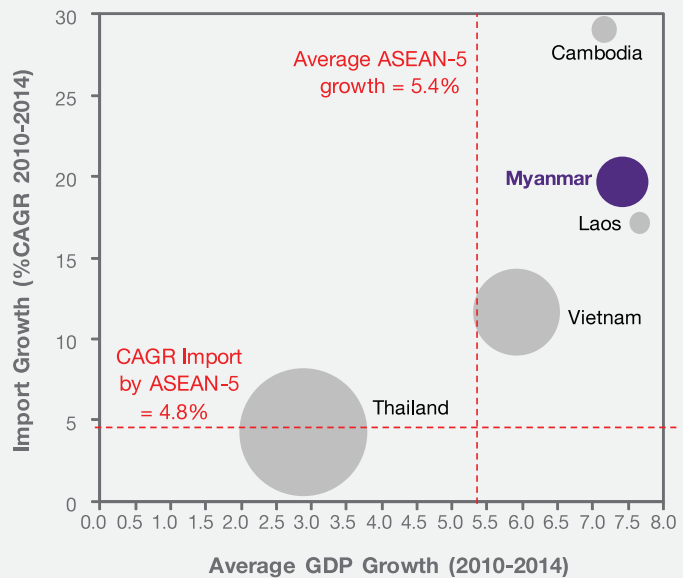


Myanmar's Inflation has been soaring above 6% due to recent overheated economy. (as of Aug 2016)

Myanmar's domestic market has potential in terms of its high growth in imports and GDP, as well as its large number of population.



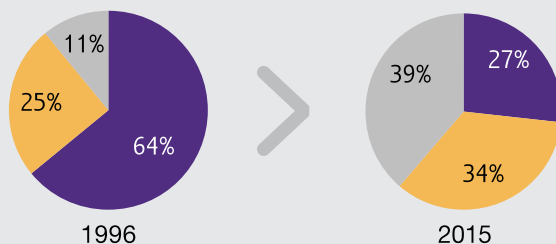
ASEAN5: Thailand, Indonesia, Malaysia, Singapore and the Philippines

New Law Updates (as of December 2016)

New Companies Act (CA)

The new CA targets to strengthen Myanmar's economy by creating a set of clear, transparent, and consistent regulations with better corporate governance and accountability. The law has now been under review at the finance ministry.

New Investment Law (IL)

The 2012 Foreign Investment Law (FIL) and the 2013 Myanmar Citizens Investment Law (MCIL) have finally been merged into the new "Investment Law (IL)" by the government since Oct 5. Foreign and Myanmar investors are now covered in the same law. The new IL is designed to simplify the investment process with international investment rules, and make investing in certain regions and sectors more attractive.

Minimum Capital Requirements

- Service company \$50,000
- Manufacturing company \$150,000



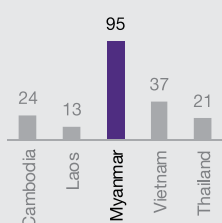
Cost of Doing Business and Taxation in Myanmar

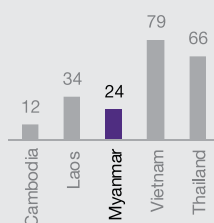

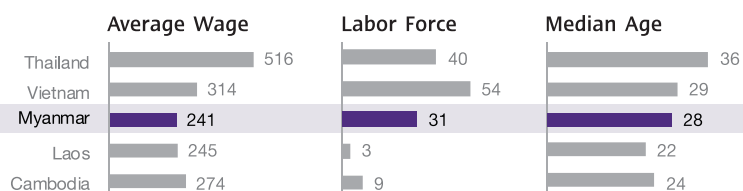
